



#### NOT INTENDED FOR USE AS A PRIMARY HEAT SOURCE.

This appliance is tested and approved as either supplemental room heat or as a decorative appliance. It should not be factored as primary heat in residential heating calculations.

**Note**: To assure top performance, safety and efficiency, inserts must be installed with an approved flue liner as per CAN/CGA B-149 or National Fuel Gas Code ANSI Z223 and these instructions.

**Note:** This installation must conform with local codes. In the absence of local codes you must comply with the National Fuel Gas Code, ANSI Z223.1-latest edition in the U.S.A. and the CAN/CGA B149 Installation Codes in Canada.

## C. High Altitude Installations

U.L. Listed gas appliances are tested and approved without requiring changes for elevations from 0 to 2000 feet in the U.S.A. and Canada.

When installing this appliance at an elevation above 2000 feet, it may be necessary to decrease the input rating by changing the existing burner orifice to a smaller size. Input rate should be reduced by 4% for each 1000 feet above a 2000 foot elevation in the U.S.A., or 10% for elevations between 2000 and 4500 feet in Canada. If the heating value of the gas has been reduced, these rules do not apply. To identify the proper orifice size, check with the local gas utility.

If installing this appliance at an elevation above 4500 feet (in Canada), check with local authorities.

# **A** WARNING

Do NOT use this appliance if any part has been under water. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control which has been under water.

## D. Non-Combustible Materials Specification

Material which will not ignite and burn. Such materials are those consisting entirely of steel, iron, brick, tile, concrete, slate, glass or plasters, or any combination thereof.

Materials that are reported as passing ASTM E 136, Standard Test Method for Behavior of Materials in a Vertical Tube Furnace at 750° C, shall be considered non-combustible materials.

#### E. Combustible Materials Specification

Materials made of or surfaced with wood, compressed paper, plant fibers, plastics, or other material that can ignite and burn, whether flame proofed or not, or whether plastered or unplastered shall be considered combustible materials.

#### F. Electrical Codes

**NOTICE:** This appliance must be electrically wired and grounded in accordance with local codes or, in the absence of local codes, with National Electric Code ANSI/NFPA 70-latest edition or the Canadian Electric Code CSA C22.1.

 A 110-120 VAC circuit for this product must be protected with ground-fault circuit-interrupter protection, in compliance with the applicable electrical codes, when it is installed in locations such as in bathrooms or near sinks.

# A. Design and Installation Considerations

Heat & Glo direct vent gas appliances are designed to operate with all combustion air siphoned from outside of the building and all exhaust gases expelled to the outside. No additional outside air source is required.

#### **CAUTION**

Check building codes prior to installation.

- Installation MUST comply with local, regional, state and national codes and regulations.
- Consult insurance carrier, local building, fire officials or authorities having jurisdiction about restrictions, installation inspection, and permits.

Heat & Glo gas inserts are designed for recessed installations into solid fuel masonry or factory built non-combustible fireplaces that have been installed in accordance with the National, Provincial, State and local building codes.

Prior to installing the gas insert:

- Have the chimney and adjacent structure inspected and cleaned by qualified professionals. Hearth & Home Technologies recommends that NFI or CSIA certified professionals, or technicians under the direction of certified professionals, conduct a minimum of a NFPA 211 Level 2 inspection of the chimney.
- Replace component parts of the chimney and fireplace as specified by the professionals.
- Ensure all joints are properly engaged and the chimney is properly secured.

When planning an appliance installation, it's necessary to determine the following information <u>before</u> installing:

- · Minimum fireplace size. See Section 3.A.
- · Gas supply piping.
- · Electrical wiring.
- · Finishing details.
- Existing mantel projections. See Section 10.
- Whether optional accessories—devices such as a fan, wall switch, or remote control—are desired.

# C. Inspect Appliance and Components



## **A** WARNING

- The fiber logs may be packaged separately and must be field installed.
- Report to your dealer any parts damaged in shipment, particularly the condition of the glass.
- Read all of the instructions before starting the installation. Follow these instructions carefully during the installation to ensure maximum safety and benefit.

# D. Inspect Firebox

Surface cracking or crazing of firebrick material is normal and expected. The following types of cracks are acceptable and do not require replacement of the unit or the firebox:

- Cracks that do not propagate entirely through the material.
- Light fracture lines or "spider-webbing" on the surface of the material.
- Cracks that are less than 1/32 in. wide and less than 3 in. long.
- If cosmetically unacceptable, such cracks may be repaired with the SRV-PACK service kit. See Service Parts List.

Cracks that are unacceptable:

- Cracks greater than 1/32 in. wide and 3 in. long are at risk of growing.
- Cracks that penetrate entirely through the firebrick material.

Inspection for cracking should be run when the appliance is cool. Cracks tend to close as the appliance heats up.

# Fireplace Size Requirements


# A. Minimum Fireplace Opening

Minimum fireplace opening requirements are shown in Figure 5.1.

WARNING! Risk of Fire or Burns! Provide adequate clearance around air openings and for service access. Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies.

- The firebrick (refractory), glass doors, screen rails, screen mesh and log grates can be removed from a factory built firebox in order to gain minimum gas insert opening requirements.
- Any smoke shelves, shields and baffles may be removed from the factory built firebox if attached with mechanical fasteners.
- The metal floor of the solid fuel firebox may be removed to facilitate the installation of the insert. The appliance may not be placed directly on the base of the outer wrap, a 1/4 inch airspace must be provided between the insert and the floor of the outer wrap. Use the levelling legs to raise the insert a minimum of 1/4 inch. The original fireplace may never be returned to solid fuel in this condition. The sidewalls and top structure of the firebox may not be altered with the exception of removable baffles and dampers.
- Cutting of any sheet metal parts of the fireplace in which the gas fireplace insert is to be installed is prohibited, except the floor as tested for and as noted above.

NOTE: For actual appliance dimensions refer to Section 15.




Figure 3.2 Clearances to Mantels or other Combustibles above Appliance





Figure 3.3 Clearances to Mantels or other Combustibles above Appliance when using Galleria or Halston Doors

# A. Vent Table Key

# **B.** Horizontal Venting

Horizontal venting is NOT allowed.

# C. Measuring Standards

Vertical measurements listed in the vent diagram (Figure 5.1) were made using the following standard:

· Vertical terminations are measured to top of chimney.



# **Installation Preparation**

Prepare the existing solid fuel masonry or factory built non-combustible firebox for installation.

## A. Flue Damper

Fully lock the solid fuel fireplace's flue damper in the open position, OR completely remove it.

## **B.** Chimney

- Ensure chimney is constructed of non-combustible materials.
- Ensure chimney is clean and in good working order.
- Ensure that all chimney cleanouts fit properly to prevent air leakage into chimney.

#### C. Gas Line

**Note:** If the factory built fireplace has no gas access hole provided, an access hole of 1 inch (25 mm) diameter or less may be drilled through the lower sides or bottom of the firebox in a proper workmanship - like manner. This access hole must be plugged with non-combustible insulation after the gas supply line has been installed.

- Install gas line into firebox cavity.
- Check local codes and gas line sizing requirements following NFPA54. See Section 8.

#### D. Hearth or Hearth Extension

# **A WARNING**



A hearth or hearth extension (if present) <u>must</u> comply with either of the following:

- The solid fuel burning fireplace manufacturer's specification.
- Local building codes required by authority having jurisdiction.
- NFPA 211

# E. Fireplace Conversion Notice

Permanently attach the label with the following warning to the inside lower back of the fireplace firebox into which the insert is being installed. Silicone may be required to properly secure the label.


This fireplace has been converted for use with a gas fireplace insert only and cannot be used for burning wood or solid fuels unless all original parts have been replaced, and the fireplace reapproved by the authority having jurisdiction.

Prior to installing the gas insert:

- Have the chimney and adjacent structure inspected and cleaned by qualified professionals. Hearth & Home Technologies recommends that NFI or CSIA certified professionals, or technicians under the direction of certified professionals, conduct a minimum of a NFPA 211 Level 2 inspection of the chimney.
- Replace component parts of the chimney and fireplace as specified by the professionals.
- Ensure all joints are properly engaged and the chimney is properly secured.

#### F. Remote Control

The receiver for the remotes must be installed <u>BETWEEN</u> the base pan of the insert and the firebox of the wood-burning fireplace (see photo below).



# **Installing Vent Pipe and Appliance**

# A. Venting Components




The vertical vent termination system installed on this model includes:


- One 3-foot section stainless steel flexible pipe (included with insert).
- One length of 3-inch flexible vent pipe for combustion air (included with vent kit).
- Flexible vent pipe for exhaust air (included with vent kit).
- One pipe-to-cap adaptor (included with vent kit).
- · One vertical termination cap (included with vent kit).

# **B.** Connecting Vent Pipe

Reference instructions in the termination kit.

- Install the 3-inch flexible vent pipe(s) down through the chimney.
- Secure the exhaust flexible vent pipe to the 3 foot section stainless steel flexible vent pipe using the factoryinstalled 3-inch collar in the stainless steel section of pipe (see Figure 7.1).
- Use 3 screws to attach either a 4 foot or 30 foot section of inlet air vent to the inlet collar on the collar slide plate (see Figure 7.1). NOTE: The collar slide plate may be removed from appliance to aid installation.
- Seal opening between flex vent and chimney just above insert. Unfaced fiberglass insulation may be used for this purpose.





- Trim chimney top plate to minimize excess overhang or bend over flue tile (see Figure 7.2).
- Place 3/8 inch bead of 300° F silicone on flue tile top.

# C. Placing, Securing and Leveling the Appliance

- Install insert (without surround attached) into existing fireplace while pulling collar slide plate forward.
- Install gas line into hole provided on insert side.
- If applicable install remote control wires into insert side (see Section 6, F.).
- Secure collar slide plate to appliance by placing locking handle into position with locking tabs (see Figure 7.1) and secure with #8 screw.
- Level the appliance from side to side and front to back. If necessary, use the leveling legs included with the insert to set each corner of the base.
- Position any excess flexible vent pipe back up into chimney without sagging. Twist and push flex vent together to shorten.
- Install fiberglass insulation pieces to back face of surround.
- Attach surround. Follow instructions accompanying surround.
- Push insert so that surround becomes tight against face of fireplace.

## **A WARNING**



Fire Risk.

Only an approved Hearth & Home Technologies surround may be used to cover integral grills on solid fuel burning fireplaces.

 No other components such as shrouds, sheetmetal plates, etc., may be used to seal off vents.



- Connect vent sections per installation instructions.
- The 3 foot section of stainless steel flexible pipe <u>MUST</u> be attached directly to the exhaust collar on the collar slide plate.
- Connect exhaust vent pipe ONLY to exhaust starting collar and termination cap center collar.
- Connect inlet air vent ONLY to inlet air collar on appliance and either the termination cap inlet air collar OR terminate within chimney.
- Do NOT allow vent to sag below connection point to appliance.

# D. Installing Adaptor and Termination Cap

For installation of termination cap see minimum vent heights for various pitched roofs (see Figure 7.2).

To install adaptor see Figure 7.3.






### Damper Flashing Kit (Optional)

For use with LINK-DV4-30B Liner Kit.


Note: Damper may have to be removed to use this kit.

- · Run flex liners through 3" holes in damper flashing.
- Attach damper flashing to firebox roof with self tapping screws included in kit.



To help eliminate cold air drafts, it may be necessary to place non-combustible insulation around the flues as they go though the damper.

**Note**: The LINK-DV4-30B system REQUIRES this insulation.

# **Gas Information**

#### A. Fuel Conversions

Before making gas connections ensure that appliance being installed is compatible with the available gas type.

Any natural or propane gas conversions necessary to meet the appliance and locality needs must be made by a qualified technician using Hearth & Home Technologies specified and approved parts.

#### **B.** Gas Pressures

Proper input pressures are required for optimum appliance performance. Gas line sizing requirements need to be made following NFPA54.



- Disconnect gas supply piping BEFORE pressure testing gas line at test pressures above 1/2 psig.
- Close the manual shutoff valve BEFORE pressure testing gas line at test pressures equal to or less than 1/2 psig.

# **▲** WARNING



- · High pressure may cause overfire condition.
- · Low pressure may cause explosion.



 Verify minimum pressures when other household gas appliances are operating.

Install regulator upstream of valve if line pressure is greater than 1/2 psig.

#### C. Gas Connection

**Note:** Have the gas supply line installed in accordance with local building codes, if any. If not, follow ANSI 223.1. Installation should be done by a qualified installer approved and/or licensed as required by the locality. (In the Commonwealth of Massachusetts installation must be performed by a licensed plumber or gas fitter).

**NOTE:** A listed (and Commonwealth of Massachusetts approved) 1/2 inch (13 mm) T-handle manual shut-off valve and flexible gas connector are connected to the 1/2 inch (13 mm) control valve inlet.

 If substituting for these components, please consult local codes for compliance.

Refer to **Reference Section 15** for location of gas line access in appliance.

**NOTE:** Gas line may be run from either side of the appliance provided the hole in the outer wrap does NOT exceed 2-1/2 inches in diameter and does not penetrate the firebox.

# A. Wiring the Appliance


# C. Installation for Fan (Optional)

On units already installed removal of decorative front, surround and gas insert is required.

- Detach flexible liner from back of unit if insert is installed.
- · Remove the four screws on the cover plate (see Figure 9.3).



- Bend up the tabs on the base pan (see Figure 9.4).
- Place the blower in between the bend up tabs.
- Install and wire the blower per instruction shipped with the fan.
- The ground wire of the fan can clip on the side of the base pan.
- Reinstall the cover plate back on the unit. Make sure the fan does not make contact with the back wall to prevent noise from vibration.





# 10 Finishing

# A. Mantel Projections

Figure 10.1 shows the minimum vertical and corresponding maximum horizontal dimensions of appliance mantels or other combustible projections above the top front edge of the appliance, not the surround. See Figure 10.2 for required clearances when using Halston or Galleria Doors.

**Note:** When using Galleria or Halston Doors with FB-GRAND-S and FB-IN-S, a 19-1/8 inch minimum vertical distance from top of unit to bottom of mantel is required.






# **B. Installing Trim Surrounds**

Combustible materials **MUST NEVER** overlap onto the front face.

- 1. Find the coiled low voltage wires and ON/OFF switch attached to outer right side of the insert (see Figure 10.2).
- Reconnect the low voltage wires to the ON/OFF switch.
- 3. Attach surround assembly by hooking the support bracket on the locating tabs on top of the gas insert fireplace (see Figure 10.2.) Once the surround assembly is on the locating tabs, ensure the bottom hooks are resting on the locating pins at the base. Reposition the fireplace if necessary. Refer to surround instructions provided with the decorative surround.



# A. Remove Shipping Materials

Remove shipping materials from inside or underneath the firebox.

## B. Clean the Appliance

Clean/vacuum any sawdust that may have accumulated inside the firebox or underneath in the control cavity.

#### C. Accessories

Install approved accessories per instructions included with accessories. See Service Parts List for appropriate accessories.



#### **Placing the Ember Material**

Ember material is shipped with this gas appliance. To place the ember material:

- · Embers CANNOT be placed directly over ports.
- When placing Glowing Embers® onto the burner care should be taken so that the ports are not covered. Place the dime-size ember pieces near port holes in burner top, sides and front (see Figure 11.1). Failure to follow this procedure will likely cause lighting and sooting problems.



- Place Mystic Ember over burner surface and around base of burner. Do not cover any burner port holes. Use this material to give the appliance a realistic ash bed.
- Save the remaining ember materials for use during appliance servicing. The embers provided should be enough for 3 to 5 applications.






**Locating Tabs** 



**LOG NUMBER 1 (SRV768-701):** Place log #1 onto the grate. Push log back until it rests against locating tabs A and B. Slide the log all the way to the left until the notches on the bottom of the log contact the grate bars.





**LOG NUMBER 2 (SRV768-704):** Position log #2 onto grate such that tab C fits into the slot on the bottom surface of the log. The right side of the log rests between the front grate tine and locating tine E. The cutout on the log should contact the corresponding tine.






**LOG NUMBER 3 (SRV768-705):** Position log #3 onto grate such that tab D fits into slot on bottom surface of log. Push down until log is sitting flat on grate.



# F. Glass Assembly



- 1. Turn off all electric power to the appliance.
- 2. Push in gas control knob slightly and turn clockwise to "OFF".



**NOTE:** Knob cannot be turned from "PILOT" to "OFF" unless knob is pushed in slightly. Do not force.

- **3.** Wait five (5) minutes to clear out any gas. Then smell for gas, including near the floor. If you smell gas, STOP! Follow "B" in the Safety Information located on the left side of this label. If you don't smell gas, go to next step.
- Find the pilot. The pilot is inside combustion chamber next to the main burner.



- 5. Turn knob on gas control counter clockwise to "PILOT".
- 6. Push in control knob all the way and hold in. Immediately depress red or black piezo button. It may require several depressions of the red or black piezo button until PILOT lights. If PILOT light does not light after 10 seconds, return to setp 3. Continue to hold the control knob in for about one minute after the pilot is lit. Release knob and it will pop back out. Pilot should remain lit. If it goes out, repeat steps 3 through 6.
- If knob does not pop up when released, stop and immediately call your service technician or gas supplier.
- If the pilot will not stay lit after several tries, turn the gas control knob to "OFF" and call your service technician or gas supplier.
- 7. Turn gas control knob counterclockwise to "ON".
- 8. To light Burner, flip the on/off switch to the "ON" position, and close access grille.
- 9. Turn on all electric power to the appliance.




## C. Check Pilot Flame Appearance

Pilot flame must contact the thermocouple and thermopile for reliable appliance operation.

Pilot flame should be as shown in Figure 12.1.



- If adjustment is needed remove cap screw from gas valve using 1/8 inch standard screwdriver (see Figure 12.2.)
- Turn adjustment screw clockwise to increase pilot flame size. Make small adjustments.



- Do <u>NOT</u> turn adjustment screw counter-clockwise too far as it will come out of the valve allowing gas to escape.
- · Replace cap screw and seal to prevent gas leaks.
- Check for gas leaks after tightening.

### D. After Appliance is Lit



## WARNING

Glass door must be in place when appliance is operating.

#### Risk of:



- · Combustion Fumes
- Fire

Do NOT operate appliance with glass door removed.

- · Open viewing glass for servicing only.
- Glass door MUST be in place and sealed before operating appliance.

#### **Initial Break-in Procedure**

When you light the appliance, you may notice that it produces heat which does have an associated odor or smell. If you feel this odor is excessive it may require the initial three to four hour continuous burn on high followed by a second burn up to 12 hours to fully drive off any odor from paint and lubricants used in the manufacturing process. Condensation of the glass is normal.

**Note:** The appliance should be run three to four hours on the initial start-up. Turn it off and let it cool completely. Remove and clean the glass. Replace the glass and run the appliance for an additional 12 hours. This will help to cure the products used in the paint and logs.

During this break-in period it is recommended that some windows in the house be opened for air circulation. This will help avoid setting off smoke detectors, and help eliminate any odors associated with the appliance's initial burning.

# E. Frequently Asked Questions

ISSUE	SOLUTIONS
Condensation on the glass	This is a result of gas combustion and temperature variations. As the appliance warms, this condensation will disappear.
Blue flames	This is a result of normal operation and the flames will begin to yellow as the appliance is allowed to burn for 20 to 40 minutes.
Odor from appliance	When first operated, this appliance may release an odor for the first several hours. This is caused by the curing of the paint and the burning off of any oils remaining from manufacturing and might set off home smoke detectors.
Film on the glass	This is a normal result of the curing process of the paint and logs. Glass should be cleaned within 3 to 4 hours of initial burning to remove deposits left by oils from the manufacturing process. A non-abrasive cleaner such as gas fireplace glass cleaner may be necessary. See your dealer.
Metallic noise	Noise is caused by metal expanding and contracting as it heats up and cools down, similar to the sound produced by a furnace or heating duct. This noise does not affect the operation or longevity of the appliance.
Is it normal to see the pilot flame burn continually?	In a standing pilot system the pilot will always stay on.

# 13 Troubleshooting

With proper installation, operation, and maintenance your gas appliance will provide years of trouble-free service. If you do experience a problem, this troubleshooting guide will assist a qualified service person in the diagnosis of a problem and the corrective action to be taken. This troubleshooting guide can only be used by a qualified service technician.

# A. Standing Pilot Ignition System

#### A. Maintenance Tasks

Although the frequency of appliance servicing and maintenance will depend on use and the type of installation, a qualified service technician should perform an appliance checkup at the beginning of each heating season.

## **A WARNING**

#### Before servicing:

- · Turn off gas.
- · Turn off electricity to appliance.
- · Disable remote control, if one is present.
- · Ensure appliance is completely cooled.

#### After servicing:

- · Replace any screen or barrier that was removed.
- · Reseal and reinstall any venting removed for servicing.

Annual inspection by qualified technician recommended.

#### Check

- · Condition of doors, surrounds and fronts.
- · Condition of glass, glass assembly and glass seal.
- · Obstructions of combustion and ventilation air.
- · Condition of logs.
- · Condition of firebox.
- · Burner ignition and operation.
- Burner air shutter adjustment
- · Gas connections and fittings.
- · Obstructions of termination cap.

#### Clean:

- Glass
- Air passageways, grilles, control compartment
- · Burner, burner ports

#### Risk of:

- Fire
- · Delayed ignition or explosion
- Exposure to combustion fumes
- Odors

Handle glass assembly with care.

NOTE: Clean glass after initial 3-4 hours operation. Longer operation without cleaning glass may cause a permanent white film on glass.

#### When cleaning glass door:

- Avoid striking, scratching or slamming glass.
- · Do NOT use abrasive cleaners.
- Use a hard water deposit glass cleaner on white film.
- · Do NOT clean glass when hot.
- Turn off appliance after 3-4 hours of operation and ALLOW TO COOL.
- Remove and clean glass assembly.
- Replace glass assembly and operate appliance for additional 12 hours.




Figure 15.1 Appliance Dimensions

## **B. Vent Kits Components**

Direct Vent Flex Liner Kits (see Figure 15.2)

LINK-DV-30B or (LINK-DV-30): Masonry 3 inch flex liner kit. Expands to 30 feet. Includes: two liners, termination cap, flashing, and link adapter.

LINK-DV4-30B or (LINK-DV4-30): Masonry 3 inch flex liner kit. Expands to 30 feet and 4 feet respectively. Includes: two liners, termination cap, flashing, and link adapter.



Direct Vent Flex Liner Accessory Kits (see Figure 15.3)

Flash-Damp: Zero clearance damper flashing kit for use with LINK-DV-30B or LINK-DV4-30B liner kits.


LINK-ZC-ADP: Zero clearance chimney adapter

# Hearth & Home Technologies Inc. LIMITED LIFETIME WARRANTY

Hearth & Home Technologies Inc., on behalf of its hearth brands ("HHT"), extends the following warranty for HHT gas, wood, pellet, coal and electric hearth appliances that are purchased from an HHT authorized dealer.

#### **WARRANTY COVERAGE:**

HHT warrants to the original owner of the HHT appliance at the site of installation, and to any transferee taking ownership of the appliance at the site of installation within two years following the date of original purchase, that the HHT appliance will be free from defects in materials and workmanship at the time of manufacture. After installation, if covered components manufactured by HHT are found to be defective in materials or workmanship during the applicable warranty period, HHT will, at its option, repair or replace the covered components. HHT, at its own discretion, may fully discharge all of its obligations under such warranties by replacing the product itself or refunding the verified purchase price of the product itself. The maximum amount recoverable under this warranty is limited to the purchase price of the product. This warranty is subject to conditions, exclusions and limitations as described below.

#### **WARRANTY PERIOD:**

Warranty coverage begins on the date of installation. In the case of new home construction, warranty coverage begins on the date of first occupancy of the dwelling or six months after the sale of the product by an independent, authorized HHT dealer/ distributor, whichever occurs earlier. The warranty shall commence no later than 24 months following the date of product shipment from HHT, regardless of the installation or occupancy date. The warranty period for parts and labor for covered components is produced in the following table.

The term "Limited Lifetime" in the table below is defined as: 20 years from the beginning date of warranty coverage for gas appliances, and 10 years from the beginning date of warranty coverage for wood, pellet, and coal appliances. These time periods reflect the minimum expected useful lives of the designated components under normal operating conditions.

## D. Limited Lifetime Warranty (continued)

#### **WARRANTY CONDITIONS:**

- This warranty only covers HHT appliances that are purchased through an HHT authorized dealer or distributor. A list of HHT authorized dealers is available on the HHT branded websites.
- This warranty is only valid while the HHT appliance remains at the site of original installation.
- Contact your installing dealer for warranty service. If the installing dealer is unable to provide necessary parts, contact
  the nearest HHT authorized dealer or supplier. Additional service fees may apply if you are seeking warranty service
  from a dealer other than the dealer from whom you originally purchased the product.
- Check with your dealer in advance for any costs to you when arranging a warranty call. Travel and shipping charges for parts are not covered by this warranty.

#### **WARRANTY EXCLUSIONS:**

This warranty does not cover the following:

- Changes in surface finishes as a result of normal use. As a heating appliance, some changes in color of interior and
  exterior surface finishes may occur. This is not a flaw and is not covered under warranty.
- Damage to printed, plated, or enameled surfaces caused by fingerprints, accidents, misuse, scratches, melted items, or other external sources and residues left on the plated surfaces from the use of abrasive cleaners or polishes.
- Repair or replacement of parts that are subject to normal wear and tear during the warranty period. These parts include: paint, wood, pellet and coal gaskets; firebricks; grates; flame guides; and the discoloration of glass.
- Minor expansion, contraction, or movement of certain parts causing noise. These conditions are normal and complaints related to this noise are not covered by this warranty.
- Damages resulting from: (1) failure to install, operate, or maintain the appliance in accordance with the installation instructions, operating instructions, and listing agent identification label furnished with the appliance; (2) failure to install the appliance in accordance with local building codes; (3) shipping or improper handling; (4) improper operation, abuse, misuse, continued operation with damaged, corroded or failed components, accident, or improperly/incorrectly performed repairs; (5) environmental conditions, inadequate ventilation, negative pressure, or drafting caused by tightly sealed constructions, insufficient make-up air supply, or handling devices such as exhaust fans or forced air furnaces or other such causes; (6) use of fuels other than those specified in the operating instructions; (7) installation or use of components not supplied with the appliance or any other components not expressly authorized and approved by HHT; (8) modification of the appliance not expressly authorized and approved by HHT in writing; and/or (9) interruptions or fluctuations of electrical power supply to the appliance.
- Non-HHT venting components, hearth components or other accessories used in conjunction with the appliance.
- · Any part of a pre-existing fireplace system in which an insert or a decorative gas appliance is installed.
- HHT's obligation under this warranty does not extend to the appliance's capability to heat the desired space. Information is provided to assist the consumer and the dealer in selecting the proper appliance for the application. Consideration must be given to appliance location and configuration, environmental conditions, insulation and air tightness of the structure.

#### This warranty is void if:

- The appliance has been over-fired or operated in atmospheres contaminated by chlorine, fluorine, or other damaging chemicals. Over-firing can be identified by, but not limited to, warped plates or tubes, rust colored cast iron, bubbling, cracking and discoloration of steel or enamel finishes.
- The appliance is subjected to prolonged periods of dampness or condensation.
- There is any damage to the appliance or other components due to water or weather damage which is the result of, but not limited to, improper chimney or venting installation.

# **LIMITATIONS OF LIABILITY:**

• The owner's exclusive remedy and HHT's sole obligation under this warranty, under any other warranty, express or implied, or in contract, tort or otherwise, shall be limited to replacement, repair, or refund, as specified above. In no event will HHT be liable for any incidental or consequential damages caused by defects in the appliance. Some states do not allow exclusions or limitation of incidental or consequential damages, so these limitations may not apply to you. This warranty gives you specific rights; you may also have other rights, which vary from state to state. EXCEPT TO THE EXTENT PROVIDED BY LAW, HHT MAKES NO EXPRESS WARRANTIES OTHER THAN THE WARRANTY SPECIFIED HEREIN. THE DURATION OF ANY IMPLIED WARRANTY IS LIMITED TO DURATION OF THE EXPRESSED WARRANTY SPECIFIED ABOVE.


